RESTORATION ORDER

Whereas, recognition was granted to the institution, namely, M.D. B.Ed. College of Education, White House Public School, Gokula Nagar, Haripar, Bhuj, Kachch, Gujarat - 372001 under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an annual intake of 100 students vide order no. WRC/5-6/92/2007/14233-14239 dt. 18.04.2007.

- 2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 M.D. B.Ed. College of Education, White House Public School, Gokula Nagar, Haripar, Bhuj, Kachch, Gujarat 372001 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.
- 3. And whereas, after the receipt of affidavit dt. 13.01.2015 from the institution, a revised recognition order no. WRC/APW02129/323247/2015/144683/745 dt. 31.05.2016 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 students (Two basic units of 50 students each) from session 2015-16.
- 4. And Whereas, the matter was placed before the WRC in its 255th Meeting held on June 22-24, 2016 and the Committee decided to issue show cause notice dt. 08.08.2016 to the institution.
- 5. And whereas, reply was submitted by the institution dt. 19.08.2016 and matter was placed before the WRC in its 283^{rd} meeting held on November $14^{th} 15^{th}$, 2017 and the Committee decided as follows: -

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be Initiated as per NCTE Regulations, 2014."

- 6. And Whereas, a Conveyed letter No. WRC/APW02129/323247/B.Ed. /283rd/GUJ/2017/193008-3013 dt. 20.11.2017 was issued to the institution.
- 7. And whereas, reply was submitted by the institution dt. 23.12.2017 and matter was placed before the WRC in its 292nd meeting held on May 15th 17th, 2018 and the Committee decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 08.08.2016 followed by a compliance letter dated 20.11.2017 were issued.

The institution replied vide letter dated 23.12.2017. The institution has not submitted the staff profile approved by the Registrar. The institution has also not submitted the Building Completion Certificate signed by the Government Engineer.

Hence, Recognition is withdrawn from the next academic session 2018-2019."

- 8. And Whereas, Withdrawal order No. WRC/APW02129 / 323247 /Guj. /292nd/2018/197977 197984 dt. 22.03.2018 was issued to the institution due to non compliance of NCTE Regulations, 2014.
- 9. And Whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the W.R.C for revisiting the matte, after the appellant institution submits required documents and taking further action expeditiously. The Council hereby remands back the case of M.D. B.Ed. College of Education, Haripar, Gokula Nagar, Bhuj, Gujarat to the WRC, NCTE, for necessary action as indicated above."

10. And Whereas, reply dt. 26.09.2018, of institution was placed before the WRC in its 299th meeting of the WRC held on October 30-November 1, 2018, and Committee decided as follows:

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

The institution vide letter dated 19.08.2016 has requested for reduction of intake from two units to one unit. On perusal of the reply dated 26.09.2018, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+7 faculty members for the year 2018-2019. As per NCTE Regulations, 2014, there must be one faculty member for Physical Education and one faculty member for Performing Arts/Visual Arts, which are not available in the list submitted by the institution.
- (ii) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 not submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

- 11. And Whereas, a Show Cause Notice No. WRC/APW02129/323247/Guj. /299th/2018/200629-200631 dt. 15.11.2018 was issued to the institution.
- 12. And Whereas, the institution submitted its replies dt. 15.12.2018, 24.01.2019, 27.04.2019 & 25.02.2019. And thereafter the institution filed S.C.A. No. 9875/2018 Converted from SCA no. 20628/2018. The Hon'ble high Court vide order dt. 28.06.2018.
- 13. And Whereas, The matter was placed before the WRC in its 308^{th} meeting of the WRC held on 23^{rd} 26^{th} July 2019, and Committee decided as follows: –

"In view of the Hon'ble High Court order dated 28/06/2018 in SCA No. 9875/2018. The committee considered the reply of the institution dated 24/01/2019. The institution has submitted a photocopy of two lecturers of Physical Education and Performing Arts. The institution is required to submit staff profile of two Lecturers as above in original as per NCTE Amended Regulations dated 09/06/2017.

Hence, the committee decided to confer last opportunity to the institution to submit the above within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993."

- 14. And Whereas, a Conveyed letter no. WRC/APW02129/323247/B.Ed./ 308^{th} / GUJ/2019/204362-365 dt. 03.07.2019 was issued to the institution.
- 15. And Whereas, reply dt. 13.06.2019, 20.06.2019 & 01.07.2019, of institution was placed before the WRC in its 309^{th} meeting of the WRC held on 23^{rd} 26^{th} July 2019, and Committee decided as follows: -

"In response to the Show Cause Notice issued on 3/7/2019. The institution has submitted reply dated 5/07/2019. The committee considered the reply and observed that staff list of two faculty members submitted by the institution as per NCTE amendment Regulations 9/6/2017.

Hence, the committee decided to restore recognition for one unit of B.Ed. Programme (50 students)."

- 16. Now Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 309th meeting and institution is permitted to continue the existing B.Ed. course of two years duration with an annual intake of 100 seats (Two basic unit of 50 seats)
- 17. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
